3. All vendors must sell only what is described on returned application (no last minute additions).
4. Booth space is limited and is on a first come first served basis. *This means: you may or may not have the same space from a previous year.*
5. No real or toy weapons: *guns, knives, or stink bombs!*
6. Booths are allowed a 10'x10' space.
7. You are responsible for trash removal and for the cleaning of your own space at the end of the day.
8. Food vendors **MUST** have a current Food Handler's Certificate. Attach a copy to this application **AND** have a copy on-site during the day of the event.
