

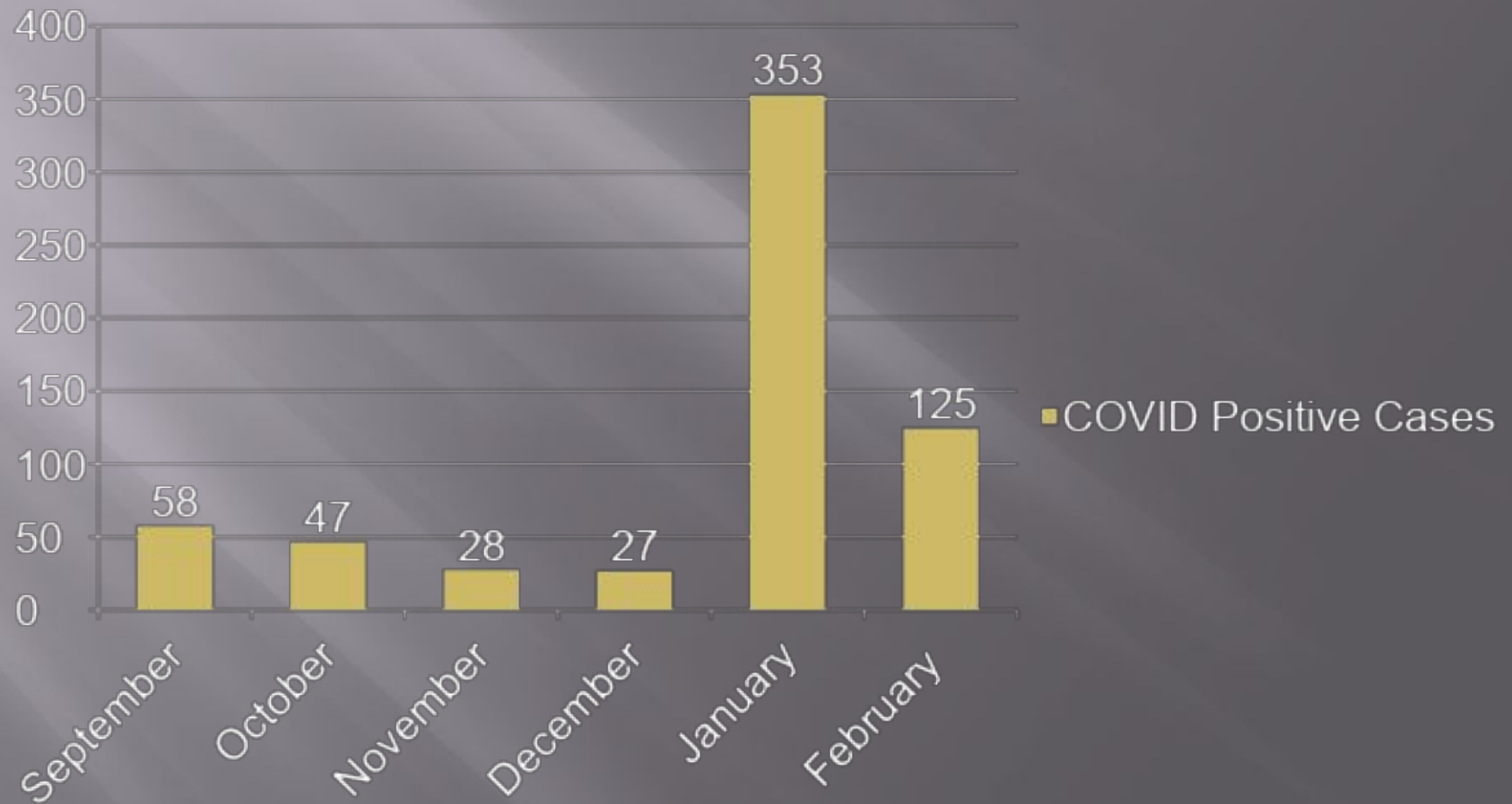

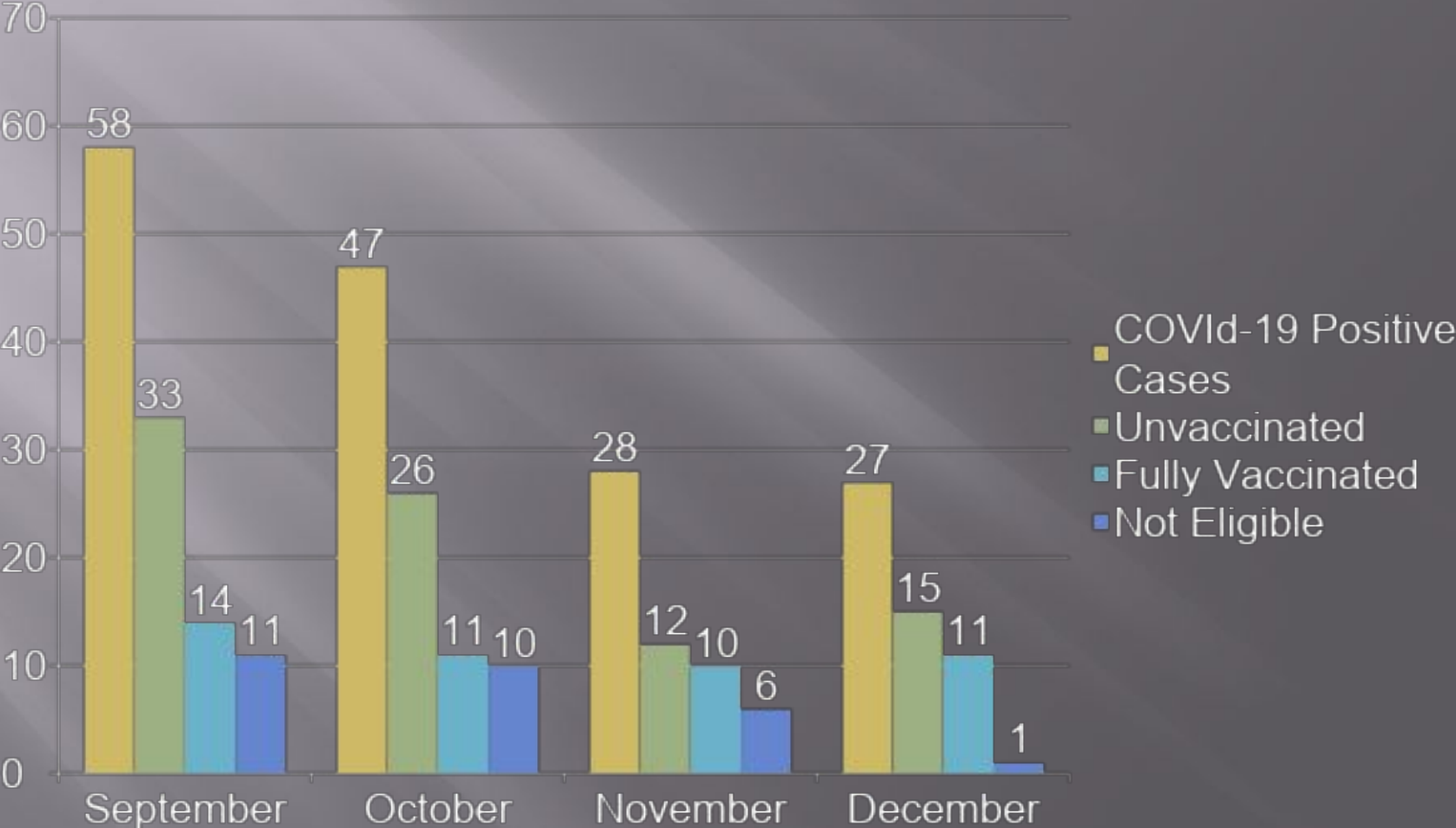
COVID Cases To Date

State of California Masking Order

- ❖ Indoor masking mandate will be lifted on 2/15/22.
- ❖ Indoor masking mandate will remain in effect for unvaccinated individuals.
- ❖ Masking mandate will remain in place for:
 - Schools
 - Hospitals/Healthcare Settings
 - Congregate Settings
 - Correctional Facilities
 - Homeless Shelters
- ❖ It will be at businesses discretion to require masks or not.

Humboldt County

- ▣ Humboldt County will align with the State of California's lift of masking orders on 2/15/22.

Hoopa Valley Tribe

&

K'ima:w Medical Center

Masking mandate will remain in effect for all Hoopa Valley Tribal Businesses and workplaces until further notice. The Hoopa Valley Tribe and K'ima:w Medical Center evaluate local data, take into consideration our high risk populations, and the fact that we have multigenerational households. Local data does not support lifting the masking orders at this time.

Hoop Valley Tribe/K'ima:w Medical Center

- ▣ HVT & KMC recommends/advises individuals to continue to wear a well fitted mask, preferably a surgical mask, K95, or and N95 masks when visiting outside communities, despite the masking order being lifted in Humboldt County and in the State of California.

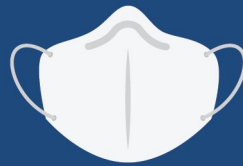

COVID Therapeutics

MONOCLONAL ANTIBODY TREATMENT

- Sotrovimab
 - Treatment for high-risk non-hospitalized patients with mild to moderate COVID-19 symptoms.
 - Single dose infusion
 - Must be administered within 10 days of onset of symptoms.
 - Treatment prescribed by KMC provider.
 - Infusion takes place at St. Joseph's Providence Hospital Infusion Center

MONOCLONAL ANTIBODY TREATMENT

- Bebtelovimab
 - Treatment for high-risk non-hospitalized patients with mild to moderate COVID-19 symptoms.

Antiviral

Remesdivir

Infusion done of a several day period.

Treatment prescribed by KMC provider.

Offered at St. Joseph's Providence Hospital.

Therapeutics Continued

ANTIVIRAL ORAL/PILL

- ▣ Paxlovid
 - Oral pill antiviral treatment of COVID-19.
 - Works by preventing replication of the virus.
 - For mild to moderate symptoms.
 - Must be taken within 5 days of onset of symptoms.
 - Prescribed by KMC providers, obtained at St. Joseph Providence Infusion Center.

ANTIVIRAL ORAL/PILL

- ▣ Molnupiravir
 - Oral pill antiviral treatment of COVID-10
 - Works by preventing replication of the virus.
 - For mild to moderate symptoms
 - Must be taken within 5 days of onset of symptoms.
 - Prescribed by KMC providers
 - Dispensed by KMC Pharmacy

Therapeutics Continued

Pre-Exposure Prophylaxis (prevention treatment)

Evusheld

- ▣ Treatment for individuals with compromised immune systems or have life threatening allergies to the COVID-19 vaccine.
- ▣ Preventative Treatment
- ▣ 2 dose injection give simultaneously
- ▣ Prescribed by KMC providers
- ▣ KMC Pharmacy has a limited supply.

Essential Personnel Isolation/Quarantine
Guidelines

Person Who Tests Positive for COVID-19 (Isolation)	Action
--	--------

Everyone, regardless of vaccination status, previous infection or lack of symptoms.

- Stay home for at least 5 days.
- Isolation can end after day 5 if symptoms are not present or are resolving and a KIMAW collected rapid antigen test on day 5 or later tests negative.
- If unable to test or choosing not to test, and symptoms are not present or are resolving, isolation can end after day 10.
- If fever is present, isolation should be continued until fever resolves.
- If symptoms, other than fever are not resolving continue to isolate until symptoms are resolving or until after day 10.
- Wear a well fitted mask around others for 10 days.

Person Who are Exposed to Someone with COVID-19 (Quarantine)

Action

- Unvaccinated**; OR
- Vaccinated and booster eligible**but have not yet received their booster dose.

**Includes persons previous infected with COVID-19, including within the last 90 days.

- Stay home for at least 5 days, after your last contact with a person who has COVID-19.
- Test on day 5.
- Quarantine can end after day 5 if symptoms are not present and a KIMAW collected rapid antigen test on day 5 or later tests negative.
- If unable to test or choosing not to test, and symptoms are not present, quarantine can end after day 10.
- Wear a well-fitting mask around others for a total of 10 days; especially in indoor settings (see Section below on masking for additional information).
- Strongly encouraged to get vaccinated or boosted.
- If testing positive, follow isolation

Persons Who are Exposed to Someone
with COVID-19
(No Quarantine)

Action

•Boosted; OR

•Vaccinated, but not yet booster-eligible

•Test on day 5 at KIMAW Medical Center.

•Wear a well-fitting mask around others for 10 days, especially in indoor settings (see Section below on masking for additional information)

•If testing positive, follow isolation recommendations above.

•If symptoms develop, test and stay home.

Definitions

Fully Vaccinated

Fully Vaccinated is currently defined as 2 weeks post having your two dose series of Moderna or Pfizer COVID-19 Vaccine, or single dose series of Johnson & Johnson.

Booster Eligibility

You are eligible for the Moderna and Pfizer COVID-19 booster vaccine 5 months after the 2nd dose in the primary two dose series, and 8 weeks after the single dose series of Johnson & Johnson. The CDC and CDPH state that if you are eligible for the booster and have not received it yet, you must quarantine if you are exposed to a COVID-19 positive individual.

Calculating Quarantine

The date of your exposure is considered day 0. **Day 1 is the first full day after your last contact with a person who has had COVID-19.** Stay home and away from other people for at least 5 days.

Living in a Household with a COVID-19 Positive Individual

If you are an employee of the Hoopa Valley Tribe or KIMAW Medical Center and you live in a household with a COVID-19 positive individual, are fully vaccinated including booster (if eligible), follow the above guideline for **Persons Who are Exposed to Someone with COVID-19 (No Quarantine)**. If you are unvaccinated or eligible for your booster and have not received it yet, follow the above guideline for **Persons Who are Exposed to Someone with COVID-19 (Quarantine)**

Quarantine/Isolations Orders Community/Non-Essential Workers

- ▣ Quarantine/Isolations Orders will remain the same until further notice.
- ▣ Positive individuals-10 day quarantine period from the onset of symptoms or positive test.
- ▣ Exposed Asymptomatic Vaccinated Individuals- test at day 5, do not need to quarantine if test is negative.
- ▣ Exposed Symptomatic Vaccinated Individuals-quarantine, test immediately, and a day 5.
- ▣ Exposed Unvaccinated Individuals- quarantine for 10 days, test at day 5.

Work Clearance Post COVID Essential Workforce.

Essential employees may test at day 5 post COVID positive test to return to work . The below criteria must be met before a work clearance may be given.

- Negative COVID test administered at KMC after day 5 of initial positive test.
- Reduced symptoms and fever free for 24 hrs
- If a COVID test is administered after day 5 and it remains positive, the individual must isolate the full 10 day isolation period.

Work Clearance Note

- ▣ Work Clearance Notes will be given to individuals upon request.
- ▣ Individuals must call Angie Brown @ 625-4261 ext. 0268 to request a Work Clearance Note. At least one day advance notice is required, in order to process notes in a timely manner.
- ▣ Work Clearance Notes will be placed in a sealed envelope and left with KMC front greeters.

Community Support KMC

- Continue to offer and advertise KMC vaccine clinics, as well as Humboldt County sponsored clinics.
- Continue to provide patient and community education on COVID-19 and vaccines.
- Continue to communicate and provide information to local school communities and staff.
- Continue to offer daily COVID-19 testing and healthcare, including providers prescribing Monoclonal Antibody Treatment for eligible COVID-19 positive patients.
- Continue to conduct follow up phone calls with COVID-19 positive patients, follow up care provided if needed.
- Continue to communicate with Humboldt County Public Health daily regarding contact tracing and new positive cases.

Comorbidity

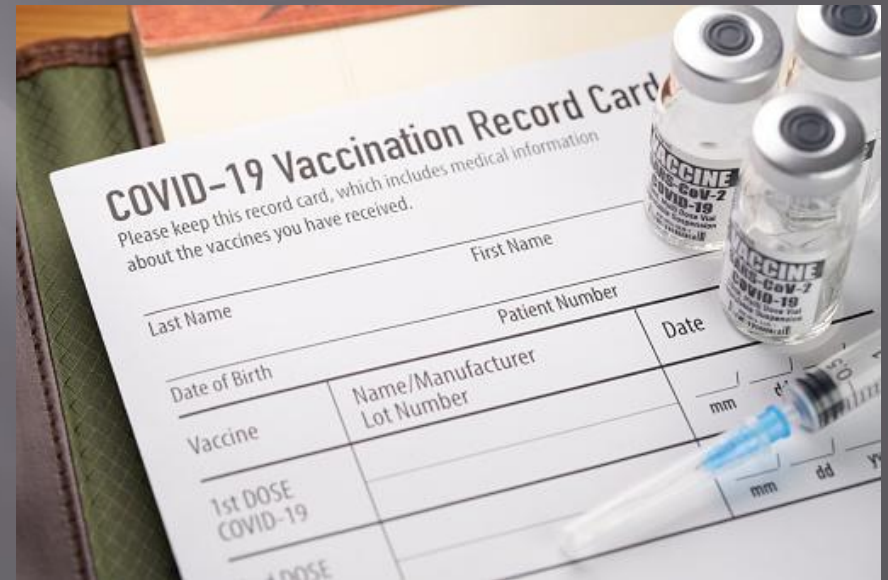
- ▣ Individuals with underlying conditions are more likely to experience greater illness and hospitalization than individuals without comorbidities.
- ▣ Age and having multiply health conditions can also contribute to increased severity of illness and hospitalizations.

Comorbidity Factors

- ▣ Age
- ▣ Number of underlying health conditions
- ▣ Long-standing systemic health and social inequities
- ▣ Individuals with disabilities
- ▣ Medical Conditions: Cancer, Chronic Kidney Disease, Chronic Liver Disease, Chronic Lung Disease, Dementia or other Neurological Conditions, Diabetes, Down Syndrome, Heart Condition, HIV Infection, Immunocompromised, Mental Health Conditions, Overweight, Pregnancy, Substance Use Disorder etc.
