**HEALTH & WELLNESS MENTOR (4):** Education Department. Regular, Full-time. Wages: \$22.00/hr. The Health and Wellness Mentor, is responsible for providing teens with positive mentorship to promote academic success, personal development, and healthy lifestyles. Responsibilities include tutoring students in core academic subjects, facilitating health and wellness activities, providing one-on-one and group mentorship, and assisting in the planning and implementation of youth programs. The Health and Wellness Mentor helps maintain a safe, inclusive, and supportive environment that aligns with the values and standards of the Hoopa Valley Tribe and the Boys & Girls Club of America. The incumbent supports the mission of the Hoopa Teen Center by providing direct services to youth in the areas of academic support, health, and wellness.

### **Minimum Qualifications:**

- High School Diploma or GED, required.
- A minimum of six months to one (1) year of experience working with youth in an educational, recreational, or mentoring setting is required.
- Experience facilitating health, wellness, or cultural enrichment activities is highly desirable.
- Prior experience working with Tribal communities or culturally diverse youth populations is preferred. Demonstrated ability to engage and motivate youth in both one-on-one and group settings.
- Must possess a valid California driver's license and be insurable under the Tribe's insurance policy.
- Ability to develop and maintain positive relationships with youth, families, Tribal departments, and community partners.
- Strong budgeting, time management, and reporting abilities.
- Ability to communicate effectively both verbally and in writing.
- Sensitivity to Tribal culture, community dynamics, and confidentiality requirements.
- Ability to maintain confidentiality and model appropriate professional behavior.
- Must be dependable, self-motivated, and able to work independently or as part of a team.
- Must be available to work flexible hours, including afternoons, evenings, weekends, and occasional holidays.
