The Hoopa Valley Tribe invites proposals from qualified & reputable catering businesses to provide a **Dinner and Service on August 6, 2026, 6:00pm – 9:00pm** for the Sovereign Days Elder Dinner 2026. The event will host approximately **250 people** at the **Hoopa Neighborhood Facility Building**. The selected caterer will be expected to deliver high-quality, traditional-themed food, diabetic friendly, professional service, and timely setup/cleanup to ensure a successful event.

Scope of Services:

- Prepare, deliver, and serve a Dinner meal for approximately 250 people
- Provide 2 main entrée options: Salmon & Deer Meat (or optional menu)
- Provide side dishes -including but not limited to: potato/macaroni salad, beans, mixed vegetables, fruit cups, homemade biscuits/rolls
- Provide beverages - Lemonade, water, coffee, other tea, and regular and diet soft drinks
- Supply all necessary serving equipment, utensils, plates, napkins, and cups, or catering equipment
- Ensure compliance with all health, safety, and food handling regulations
- Setup 2-hours before the event and cleanup after the event.

Proposal Requirements:

- Caterer Business Name, address, and contact information
- Business formation and licensing information
- Sample menu with pricing
- Staffing plan (food servers, setup, etc.)
- Description of prior catering experience for events of similar size
- Food safety certifications: Person in Charge must possess a valid food handler card in accordance with Title 56.402.
- References from at least one prior client
- Any additional services or value-added options available

Evaluation Criteria:

- Quality and variety of proposed menu
- Cost effectiveness and value
- Caterer's experience and reputation
- Ability to meet event requirements and timeline
- References and past performance
